### E - Auction Sale Notice

**SALE OF IMMOVABLE/MOVABLE PROPERTY MORTGAGED TO THE BANK UNDER THE SECURITISATION AND RECONSTRUCTION OF FINANCIAL ASSETS AND ENFORCEMENT OF SECURITY INTEREST ACT, 2002 read with Rule 6(2) & Rule 8(6) of the Security Interest (Enforcement) Rules 2002.**

Whereas M/s Kirit Khodiyar Buildcon Pvt Ltd has borrowed monies from Indian Overseas Bank against the mortgage of the immovable/movable properties more fully described in the schedule hereunder and on upon classification of the account as NPA, the Bank has issued a demand notice under Section 13(2) of the SARFAESI Act, 2002 (Act) 03.08.2019 calling upon the following borrowers M/s Kirit Khodiyar Buildcon Pvt Ltd, Directors: (1) Mr. Kirit Khushalbai Khodiyar (2) Mrs. Bhavika Kirit Khodiyar and the Guarantors/Mortgagers (1) Mr. Kirit Khushalbai Khodiyar (2) Mrs. Bhavika Kirit Khodiyar (3) Mrs. Bhavnaben Bhupendrabhai Tank (4) Mrs. Radhikaben Rajeshbhai Tank (5) Legal Heirs of Late Mrs. Lilavatiben Khushalbai Khodiyar - (1) Mr. Khushalbai Khodiyar (2) Mr. Kirit Khushalbai Khodiyar (3) Mrs. Bhavnaben Bhupendrabhai Tank (4) Mrs. Radhikaben Rajeshbhai Tank (6) Legal Heirs of Late Mr. Rajesh Shivlal Tank - (1) Mrs. Radhikaben Rajeshbhai Tank (2) Mr. Aman Rajeshbhai Tank to pay the amount due to the Bank, being Rs.2,23,19,429.57 (Rupees Two Crores Twenty-Three Lacs Nineteen Thousand Four Hundred Twenty-Nine and Paise Fifty-Seven only) as on 03.08.2019 payable together with further interest at contractual rates and rests alongwith costs, charges etc till date of repayment within 60 days from the date of receipt of the said notice.

Whereas the borrowers & guarantors having failed to pay the amount dues in full to the Bank as called for in the said demand notice, the Bank has taken possession of the secured assets more fully described in the schedule hereunder on 06.12.2019 under Section 13 (4) of the Act with the right to sell the same in "As is where is" and "As is what is" basis under Section 13(4) of the Act read with Rules 8 & 9 of the Security interest (Enforcement) Rules, 2002 for realization of Bank's dues. The dues to the bank as on the date of taking possession was intimated as Rs.2,34,56,797.57 (Rupees Two Crores Thirty-Four Lacs Fifty-Six Thousand Seven Hundred Ninety Seven and Paise Fifty-Seven only) as on 06.12.2019 payable together with further interest at contractual rates and rests alongwith costs, charges etc till date of repayment, after reckoning repayments, if any, since the date mentioned in the demand notice.

The dues of the borrower as on 11/10/2021 works out to Rs. 2,93,79,136.25 (Rupees Two Crore Ninety Three Lakh Seventy Nine Thousand One Hundred Thirty Six and Paise Twenty Five only) after reckoning repayments, if any, subsequent to the Bank issuing Demand Notice.

The undersigned in exercise of the powers conferred under Sec 13(4) of the said Act proposes to realize the Bank's dues by sale of the under mentioned properties.

### Terms and Conditions

1. The property(ies) will be sold by e-auction through the service provider <https://www.mstcecommerce.com/auctionhome/ibapi> under the supervision of the Authorized Officer of the Bank.
2. The intending Bidders /Purchasers are requested to register on portal <https://www.mstcecommerce.com/auctionhome/ibapi> using their mobile number and email-id. Further, they are requested to upload requisite KYC documents. Once the KYC documents are verified by e-auction service provider (may take 2 working days), the intending Bidders /Purchasers has to transfer the EMD amount using online mode in his Global EMD Wallet account by 28/10/2021 up to 05.00 P.M..Intending bidders shall have a valid email address and should register their name / account by login to the website of the aforesaid service provider.



3. Earnest Money Deposit (EMD) amount as mentioned above shall be paid online through NEFT/RTGS mode (After generation of Challan from <https://www.mstccommerce.com/auctionhome/ibapi> which will provide account details) in bidder's Global EMD Wallet account. Bidders, not depositing the required EMD online, will not be allowed to participate in the e-auction. Bids without EMD shall be rejected summarily. The Earnest Money Deposited shall not bear any interest. The amount of EMD paid by the successful bidder shall be adjusted towards the sale price.
4. The intending participants of e-auction may download copies of the Sale Notice, Terms & Conditions of e-auction, Help Manual on operational part of e-auction related to this e-auction from e-बिदा-IBAPI portal (<https://www.ibapi.in>).
5. The submission of online application for bid with EMD shall start from 13/10/2021.
6. Bidder's Global Wallet should have sufficient balance ( $\geq$ EMD amount) at the time of bidding.
7. Online auction sale will start automatically on and at the time as mentioned above. Auction / bidding will initially be for a period of 120 Minutes with auto extension time of TEN (10) minutes each till the sale is concluded.
8. During the e-auction bidders will be allowed to offer higher bid in inter-se bidding over and above the last bid quoted and the minimum increase in the bid amount must be of Rs. 10,000/- to the last higher bid of the bidders. TEN (10) minutes time will be allowed to bidders to quote successive higher bid and if no higher bid is offered by any bidder after the expiry of TEN (10) minutes to the last highest bid, the e-auction shall be closed.
9. The property shall be sold to the successful bidder. Failure to remit the entire amount of sale price within the stipulated period will result in forfeiture of deposit of 25% of the bid price to the secured creditor and forfeiture of all claims over the property by the purchaser and the property will be resold.
11. The sale certificate will be issued in the name of the successful bidder (purchaser) only, after payment of the entire sale price amount and other taxes/charges, if any.
12. The purchaser shall bear the charges/ fee payable for conveyance such as registration fee, stamp duty, etc., as applicable as per law.
13. The Authorized Officer has the absolute right to accept or reject any bid or postpone or cancel the sale, as the case may be without assigning any reason whatsoever.

The Bank has disclosed only the known encumbrances, statutory liabilities, if any, as above and it is for the purchaser to make their own independent enquiries at their own costs before participating in the auction.



15. As regards the statutory dues stated above, Bank dues will have priority over statutory dues. Without prejudice to the above, statutory liability, if any, shall be borne by the purchaser and the Bank assumes no responsibility in this regard.

16. Sale is subject to confirmation by the secured creditor Bank.

17. The e-auction advertisement does not constitute and will not be deemed to constitute any commitment or any representation by the bank. The Authorised Officer/Secured Creditor shall not be responsible in any way for any third party claims / rights / dues.

18.\*In compliance with Section 194 IA of the Income Tax Act, 1961 income tax @ 1% on the Reserve Price shall be deducted and paid under the PAN of the Purchaser. Since the Tax has been calculated only on the Reserve Price, the bidder shall bear the 1% income tax on the bid multiplier amount and the bank shall not take any responsibility for the same.

\*In case of any sale/transfer of immovable property of Rupees Fifty lakhs and above, the transferee has to pay an amount equal to 1% of the consideration as Income Tax.
