## **E-AUCTION SALE NOTICE**

SALE OF IMMOVABLE PROPERTY MORTGAGED TO THE BANK UNDER THE SECURITISATION AND RECONSTRUCTION OF FINANCIAL ASSETS AND ENFORCEMENT OF SECURITY INTEREST ACT, 2002

Whereas, M/s Shri Sai Electricals (Prop. Mr. Prabhakar Kawaduji Mungse) has borrowed monies from Indian Overseas Bank, against the mortgage of the immovable properties, more fully described in the schedule hereunder and the Bank has issued a Demand Notice under Section 13(2) of the SARFAESI Act, 2002 (Act) on 20.06.2023, calling upon the borrower M/s Shri Sai Electricals (Prop. Mr. Prabhakar Kawaduji Mungse) and Guarantors -- to pay the amount due to the Bank, being Rs.6,88,015.00 (Rupees Six Lakh Eighty Eight Thousand Fifteen Only), as on 19.06.2023 payable together with further interest at contractual rates and rests along with costs, charges etc. till date of repayment within 60 days from the date of receipt of the said notice.

Whereas, the borrowers & Guarantor having failed to pay the amount due to the Bank as called for in the said Demand Notice, the Bank has taken **possession (Symbolic)** of the secured assets more fully, described in the schedule hereunder on **22.12.2023** under Section 13 (4) of the Act with the right to sell the same in "As is where is", "As is what is" and 'Without Recourse Basis' under Section13(4) of the Act read with Rules 8 & 9 of the Security interest (Enforcement) Rules, 2002 for realization of Banks dues. The dues to the bank as on the date of taking possession was intimated Rs.3,35,788.00 (For CC under IOB SME EASY Scheme & FITL facilities only), as on **22.12.2023** payable together with further interest at contractual rates and rests along with costs, charges etc. till date of repayment, after reckoning repayments, if any, since the date mentioned in the demand notice.

The dues of the borrower as on 29.02.2024 works out to Rs.3,44,017.19 (CC under IOB SME EASY Scheme & FITL facilities only), after reckoning repayments, if any, subsequent to the Bank issuing demand notice.

## Terms and conditions of E-auction

- 1. The property(ies)will be sold by e-auction through the service provider <a href="https://www.mstcecommerce.com/auctionhome/ibapi">https://www.mstcecommerce.com/auctionhome/ibapi</a> under the supervision of the of the Authorized Officer of the Bank.
- 2. The intending Bidders /Purchasers are requested to register on portal <a href="https://www.mstcecommerce.com/auctionhome/ibapi">https://www.mstcecommerce.com/auctionhome/ibapi</a> using their mobile number and email-id. Further, they are requested to upload requisite KYC documents. Once the KYC documents are verified by e-auction service provider (may take 2 working days), the intending Bidders /Purchasers has to transfer the EMD amount using online mode in his Global EMD Wallet account by 29.03.2024 Intending bidders shall have a valid email address and should register their name / account by login to the website of the aforesaid service provider.
- 3. Earnest Money Deposit (EMD) amount as mentioned above shall be paid online through NEFT/RTGS mode (After generation of Challan from <a href="https://www.mstcecommerce.com/auctionhome/ibapi">https://www.mstcecommerce.com/auctionhome/ibapi</a> which will provide account details) in bidders Global EMD Wallet account. Bidders, not depositing the required EMD online, will not be allowed to participate in the e-auction. Bids without EMD shall be rejected summarily. The Earnest Money Deposited shall not bear any interest. The amount of EMD paid by the successful bidder shall be adjusted towards the sale price.

- 5. The submission of online application for bid with EMD shall start from 15.03.2024.
- 6. Bidder's Global Wallet should have sufficient balance (>=EMD amount) at the time of bidding.
- 7. Online auction sale will start automatically on and at the time as mentioned above. Auction / bidding will initially be for a period of 120 Minutes with auto extension time of ten (10) minutes each till the sale is concluded.
- 8. During the e-auction bidders will be allowed to offer higher bid in inter-se bidding over and above the last bid quoted and the minimum increase in the bid amount must be of Rs.10,000/- to the last higher bid of the bidders. Ten (10) minutes time will be allowed to bidders to quote successive higher bid and if no higher bid is offered by any bidder after the expiry of 10 minutes to the last highest bid, the e-auction shall be closed.

- 10. The balance amount of sale price shall be paid within 15 days from the date of confirmation of auction sale.
