The dues to the bank as on the date of taking possession was intimated as as Rs.21,95,822/-(Rupees twenty one lakh ninety five thousand eight hundred and twenty two Only) as on 21.9.2020 payable together with further interest at contractual rates and rests alongwith costs, charges etc till date of repayment, after reckoning repayments, if any, since the date mentioned in the demand notice.
