- Tax on pension paid to Central Government Pensioners centralised and tax for **FY 2019-20** will be deducted at CPPC.
- Tax on pension/arrears paid for **FY 2019-20** is being deducted from **Aug'19**.
- Pensioners to submit declaration of their proposed income tax related investments immediately and the proof of the investments on or before **10.02.2020**, to their pension drawing branch.
- If proof of investment details are not submitted before **10.02.2020**, Tax on the pension paid for the whole **FY19-20** including arrears if any , will be deducted at source.
- If pensioners have already paid tax, the particulars of the same may be provided along with investment details to the pension drawing branch.
