<u>Disclosure under Regulation 30 of the SEBI (LODR) Regulations, 2015</u> <u>Disciplinary Action on the Bank by Hong Kong Monetary Authority</u>

In terms of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we hereby inform you that Hong Kong Monetary Authority (HKMA) has imposed a disciplinary action on Hong Kong Branch of the Bank (IOBHK) for contravention of Section 23, 19 (3) and paragraph (c) of Section 5(1) of Schedule 2 to the Anti-Money Laundering and Counter-Terrorist Financing Ordinance (AMLO) between May 2021 to January 2024 by ordering for conducting a look-back review on the transaction alerts generated by its transaction monitoring system, submitting to the HKMA a remedial plan to address the contraventions, submitting a report prepared by an independent external advisor to the HKMA assessing whether the remedial measures are effective, and also for IOBHK to pay a pecuniary penalty.

The Bank and its branch operating at Hong Kong have taken necessary preventive actions to avoid such recurrence in future and further strengthen its internal processes in this regard. The impact of the said action on the Bank is not material.

The details as required under Point 20 Para A Part A of Schedule III to Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 are enclosed herewith as Annexure - I.
