Cameo Corporate Services Limited**, having its office situated at "Subramanian Building", No.1, Club House Road, Chennai - 600 002 pertaining to the period from **01st April, 2023 to 31st March, 2024** for the purpose of issuing a Certificate under Regulations 39 and 40 (9, 10 & 11) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 as amended (hereinafter referred to as 'SEBI LODR') and the Uniform Listing Agreement entered into by the Bank with **National Stock Exchange of India Limited**.
